Following the publication of the Department of Health Technical Memorandum HTM-07-01 titled "The Safe Management of Healthcare Waste" Amcor Flexibles are able to offer a range of colour coded sharps containers to assist in the segregation of waste as recommended in the new guide.

All Sharpak Code YELLOW sharps containers feature yellow coloured closures and are recommended for the segregation, collection and disposal of partially discharged sharps waste which are NOT contaminated with cytotoxic or cytostatic medicines.

Code YELLOW Sharpak sharps containers MUST only be disposed of by incineration.

Please note:- For disposal of sharps contaminated with cytotoxic or cytostatic medicines please refer to the Amcor Flexibles SPS data sheet for the Code PURPLE range of Sharpak HYDRI sharps containers.

All Sharpak Code YELLOW sharps containers are approved to BS7320:1990 and tested and certified in accordance with the provisions of the United Nations recommendations on the Transportation of Dangerous Goods, Chapter 9, UN3291 Clinical Waste, Unspecified, NOS.

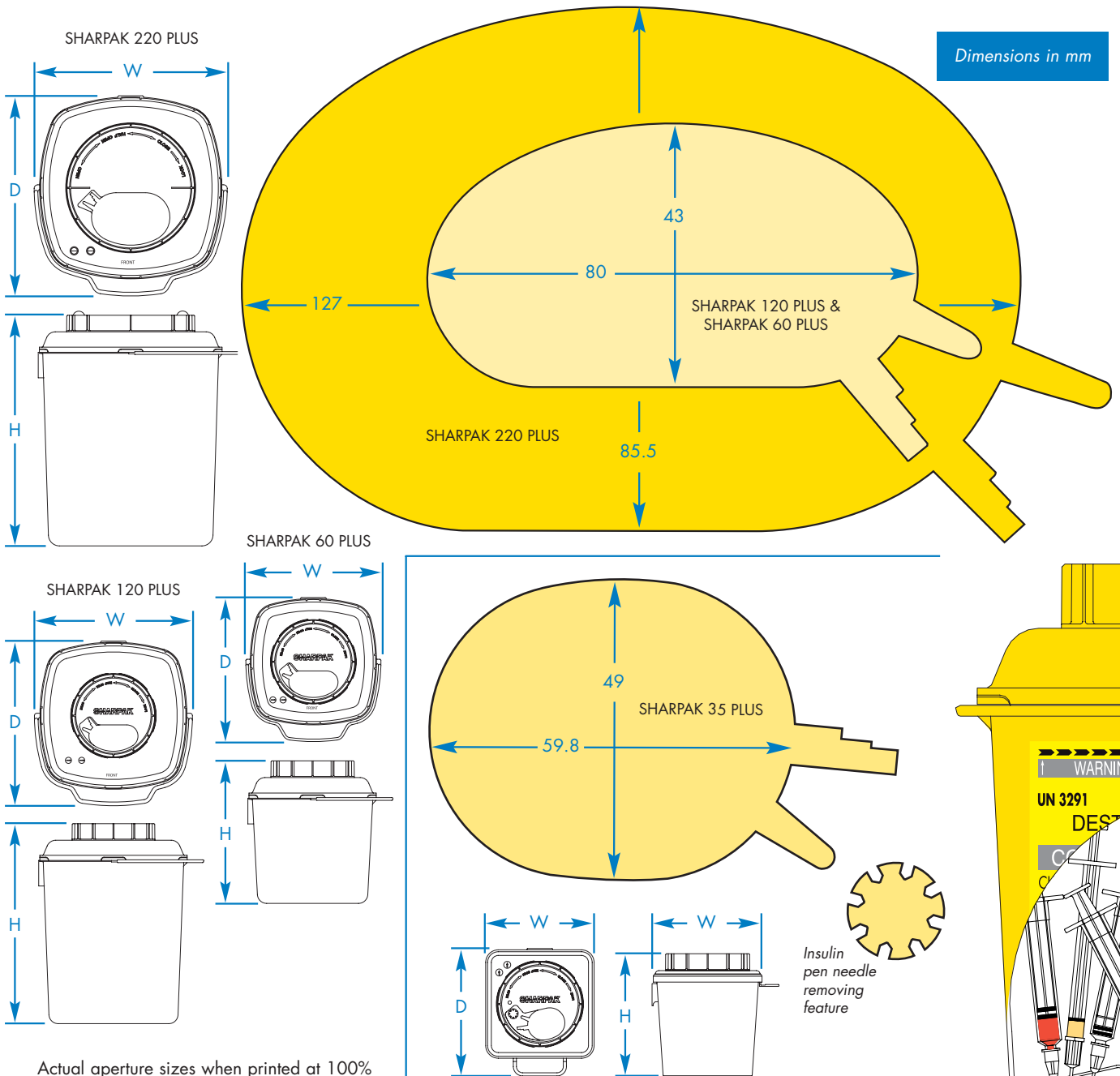
